Robert (Bob) Louis Wolz, 78, of Idaho Falls, died Tuesday, December 11, 2007, near Cedar City, Utah, of injuries sustained in a plane crash. Bob was born October 30, 1929 in Lovell, Wyoming, to Louis Larraine and Dorothy Jane Coulam Wolz. He lived his childhood in Sugar City, and Ucon. He later graduated from Rigby High School in 1947. Bob was a man with many amazing talents and interests. He had a great love for his family, friends, and an unlimited amount of faith in the Church of Jesus Christ of Latter-day Saints. He served a mission for the church in the British Mission field in 1949. After returning from his mission, he married Patsy Allen. To this union there were 2 children born Karen and Gary. They later divorced. He enlisted in US Air Force in 1957 and was discharged in 1961. He married and later divorced Marilyn Wahl. He adopted her daughters Christine and Melinda. Robert married Gayle Irish Mays Wolz October 7, 1977 in Pocatello, Idaho. Their marriage was solemnized October 7, 1978 in the Ogden Temple, Ogden Utah. He lovingly adopted her daughter Kimberly. He served as Executive Secretary in the LaBelle, Idaho 3rd Ward, High Councilman and Ward secretary. He was currently serving as Gospel Doctrine teacher in the Ammon 18th Ward, and as a Temple Officiator for the past 11 years. His many hobbies included photography, hunting, and a deep passion for aviation and flying that spanned more than 60 years. He was a master craftsman in building remote controlled airplanes as well as having a great interest in firearms. Survivors include his wife Gayle, children: Karen (Fred) Sanford of Centerville, Utah; Gary Louis (Allison) Wolz of Turlock, California; Step children: Steven (Jodie) Mays of Superior, Wisconsin; Gregory (Debbie) Mays of Idaho Falls; Martin (Connie) Mays of Rigby; James (Lisa) Mays of Mountain Home; and Kimberly Mays Wolz Pence of Idaho Falls; 19 grandchildren and 11 great grandchildren; siblings: Gerald Wolz of Rigby; Paul Wolz of Casper, Wyoming; and Dorothy Nedo of Salt Lake City, UT. He was preceded in death by a grandson and a granddaughter. I have had the humble blessing of helping to put together the events of the last four days, assisting in rescue and recovery efforts, and most of all getting to know these great men who perished in the hills I roamed as a young man, in the Minersville area. It is very difficult to explain the impression left upon me, without sobbing for the family who has lost so much, so quickly, so unexpectedly. Please allow me to bear witness that Robert truly magnified his Calling in the Church of Jesus Christ of Latterday Saints, in all he did. I have in my possession the handbag which Robert carried aboard his last flight here on this earth. In the Recovery efforts to gather the personal valuables of these great men, amongst others was found this black leather bag belonging my new friend, Robert. The contents contained something so valuable in my opinion, it is priceless! After unzipping the leather carrying case, within lied two items. The first was a "New Testament" manual, well studied, marked, and with a yellow paper clip I assume the lesson intended to give this coming Sunday. The second, priceless above that of Gold and Silver... Robert's Scriptures. As I sit here, understanding the value of these tools....I learn who this man really was. I will personally deliver these items to those whom this great man left behind as I make my way to Idaho Falls Tuesday. I look forward to making sure this "priceless" memory is returned. I do not trust it to Fed Ex, UPS, or any other freight service. The chance of losing it is just not an option. Please know that these tools he carried aboard his last flight, were certainly well used and are here in my home--warm, safe, securely protected, underneath my favorite portrait of the Savior. It is my prayer as I sit here in the comfort of my home office, the place I feel closest to the Savior, wiping a tears from my eyes....the love I feel extended from this Great Man! He has touched my life, more than one can imagine, with just this small piece of his legacy left upon the mountain tops of Southern Utah. It is my testimony that Robert is continuing his life long dedication on the other side of the veil, and is looking down upon us with that special smile....Even though he is not here with us, he continues to touch the lives of those he comes into contact with....Thank you for allowing me to give this very personal witness, that you can actually know a man without ever meeting him.
